

(U) Vision: To build an enduring, integrated, and agile USG capability for preventing and neutralizing all WMD threats

(U) WHAT DOES THE FBI WMD DIRECTORATE COVER?

- (U) All Modalities (CBRN)
 - (U) Chemical (U) Biological

(U) The FBI WMD Directorate (WMDD)



- (U) The WMDD was established in 2006 to build a cohesive and coordinated approach to the prevention, response and investigation of threats involving chemical, biological, radiological, or nuclear (CBRN) weapons.
- (U) The WMDD ensures a strategic approach to prevent and respond to the continuously evolving WMD threat.
- (U) To address the unique nature of the WMD threat, the WMDD maintains a dedicated workforce with CBRN-specific expertise and experience.



(U) CDC & WMDD PARTNERSHIP

 (U) CDC & FBI WMDD hold quarterly biosecurity conference calls

• (U) CDC & WMDD share biosecurity related information

 (U) CDC supports WMDD efforts to understand potential biosecurity concerns





(U) CDC & WMDD PARTNERSHIP

- (U) The partnership benefits the FBI because:
- 1.(U) Enhances outreach to public and private biological research institutions
- 2. (U) Provides information the FBI may not otherwise obtain:
 - (U) Select agent facility locations
 - (U) Potential violations of biosafety and biosecurity
 - (U) Suspicious activity of entities applying to import infectious material
 - (U) Suspicious activity of employees at select agent facilities





(U//FOUO) Insider Threat and Select Agent Facilities

- (U) CDC DSAT shares inspection reports with WMDCs identifying:
- (U) Personnel not following biosecurity protocol
- (U) Personnel not following biosafety protocol



- (U) Concern Because:
- (U//FOUO) Possesses knowledge of and/or access to select agent material
- (U) Some reported insider threat activity displayed by subjects associated with biological facilities:
- (U//FOUO) Unauthorized work activity
- (U//FOUO) Unauthorized removal of material
- (U//FOUO) Seeking unauthorized access to material/information



(U) Case Studies

(U//FOUO) FBI & CDC: Assessment of Suspicious Infectious Disease Import Permit Holders

- (U//FOUO) FBI Miami & CDC conduct joint assessment
- (U) Assessment uncovered probable medical fraud front companies
- (U) FBI Miami & CDC identified characteristics of fraudulent or front companies
- (U) CDC reviewed internal policies following assessment of fraudulent companies



(U) Safeguarding Science

- (U) FBI Academic Biosecurity Workshop
 - (U) Developed in 2010 for BSAT and non-BSAT institutions
 - (U) The goal is prevention through cooperation among law enforcement agencies, research institutions, and other stakeholders to mitigate potential biosecurity issues that may affect public health and safety
 - (U) Free half-day workshop with case studies, best practices, and exercise discussions
