Dear Sir/ Madam,

It is hereby informed that Board of Directors of the Company in its meeting held today i.e. Wednesday, July 14, 2021, had inter-alia decided the following:

- 1. Approved the Notice of 31st Annual General Meeting of the Company to be held on Wednesday, August 11, 2021 through Video Conferencing ("VC") / Other Audio Visual Means ("OAVM")
- 2. Further as per the RBI circular dated April 27, 2021 on Guidelines for appointment of Statutory Auditors of Banks and NBFCs ("RBI Circular"), the Company need to appoint Statutory Auditors for a continuous period of three years, subject to satisfaction of eligibility norms and independence criteria prescribed. Accordingly, Board of Directors:
 - (i) Took note of the intent letter dated July 13, 2021, received from M/s Walker & Chandiok & Co. LLP, current Statutory Auditors of the Company, communicating their intention to resign as Statutory Auditors of the Company w.e.f conclusion of 31st Annual General Meeting ("AGM") of the Company, since they have completed 4 years of continuous audit and are ineligible to continue as Statutory Auditors in terms of RBI Circular.
 - (ii) Considered and recommended for approval of the shareholders at the ensuing AGM, the appointment of M/s S S Kothari Mehta & Company, Chartered Accountants, as the Statutory Auditors of the Company for three years from the conclusion of 31st AGM up to the conclusion of 34th AGM of the Company.

Accordingly, the Board of Directors in compliance with the RBI Circular have considered, approved and recommended the appointment of SSKM as Statutory Auditors for the approval of Shareholders.
2.	Date of appointment / Term of appointment	SSKM will hold office for a period of three consecutive years from the conclusion of 31 st Annual General Meeting till the conclusion of 34 th Annual General Meeting, subject to the approval of the Shareholders of the Company.
