Qualitative Disclosure on LCR

As per Reserve Bank of India guidelines, all deposit-taking NBFCs irrespective of their asset size and non-deposit-taking NBFCs with an asset size of Rs.5,000 crore and above are required to maintain a liquidity coverage ratio (LCR) to ensure availability of adequate high-quality liquid assets (HQLA) to survive any acute liquidity stress scenario i.e, cash outflow increased to 115% and cash inflow decreased to 75%, lasting for 30 days. As per RBI guidelines, LCR has been calculated using the simple average of daily observations over the previous quarter (over a period of 90 days).

Cash outflows under secured and unsecured wholesale funding include contractual payments of the term loan, NCDs, and other debt obligations including interest payments due in next 30 days. Other contractual funding obligations include contractual payments due in next 30 days.

To compute inflow from fully performing exposures, the company considers collection from performing advances including interest due in the next 30 days. Other cash inflows include cash from unencumbered fixed deposits, Certificates of deposits, undrawn lines of credit, and mutual fund investments maturing in the next 30 days. The LCR as of March 31, 2025 is 130.40%, which is well above the regulatory requirement of 100%.

Institutional set-up for liquidity risk management	
<p>The company has a robust risk management system in place. To ensure smooth functioning of business operations, the company maintains adequate liquidity in the form of cash, bank balances, fixed deposits, T-Bills and mutual funds. The Board has the ultimate responsibility for the SCNL's risk management including liquidity risk. The Board has delegated the oversight and review of liquidity risk management to the Risk Management Committee of the Board (RMCB) which is supported by Executive Risk Management Committee (ERMC) and the Asset Liability Management Committee (ALCO). The responsibility of the ALCO is to manage liquidity risk, ensures compliance with policies, frameworks, internal limits, and regulatory limits related to ALM and update the same to the board. The Executive Risk Management Committee is responsible for overseeing the implementation of risk management framework across SCNL and providing recommendations to the RMCB. ERMC, RMCB, and ALCO meetings are held at periodic intervals.</p>
